

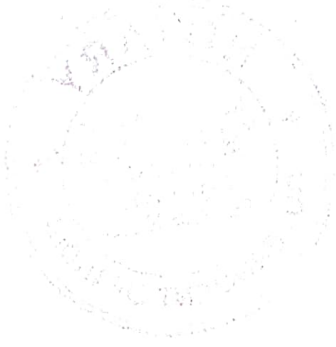
1. We are citizens of India.
