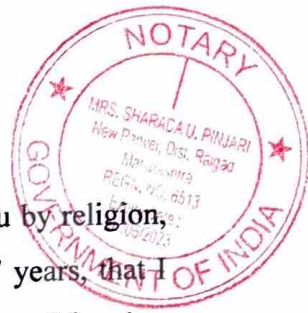

I the Deponent no. 1 say that I shall maintain look after the Deponent no. 2 herein and shall lead happy married life with her.

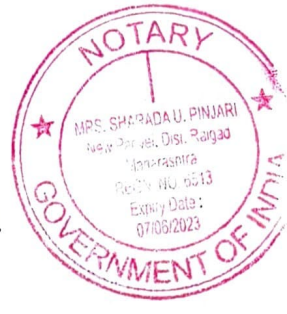
I the Deponent no. 2 say and declare that after marriage I shall be known as “**MRS. MANASI BHARAT SUTAR**”



