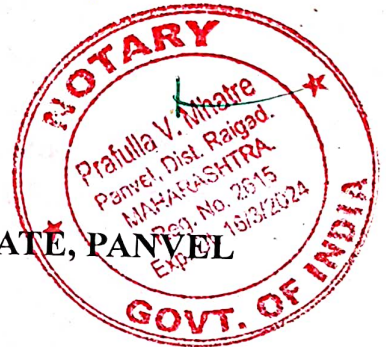

Do hereby solemnly affirms on oath and jointly declare as under:

1. I, Shri. Amrut Hanmant Shintre (“Deponent No. 1”) was married to one Ronita Dwipendra Basu in the year 2011 according to Hindu Vedic Rites and Rituals.

2. I say that due to our indifferences, by vide order date 11/04/2018, we got our marriage dissolved by mutual consent before the Hon’ble Family Court No. 2 Mumbai.

4. I Deponent No. 1 say that the present marriage is my second marriage after dissolving the first marriage as per order 11/04/2018 of Family Court Bandra.

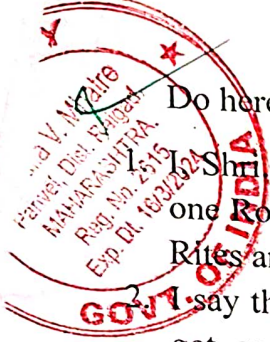

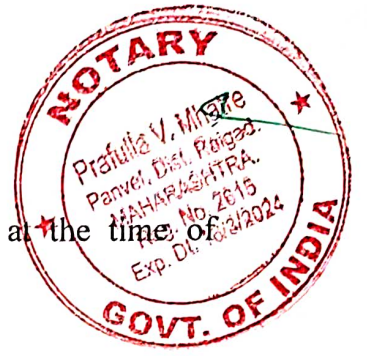

13. We the deponents / Applicants do hereby solemnly declare that whatever is stated in the said affidavit is true to our knowledge, and we believe the same to be true.



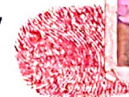
