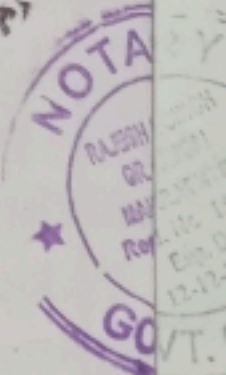



However since the wedding card was not printed the same is not available with us.



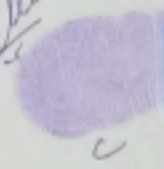

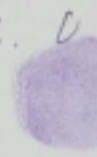


I state that I left my parents home with my own will and free consent without taking any cash and jewellery, I have only my own clothes, which I wear.
