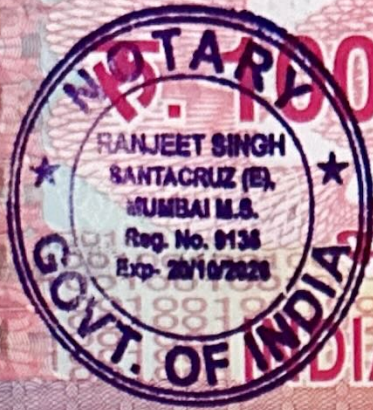

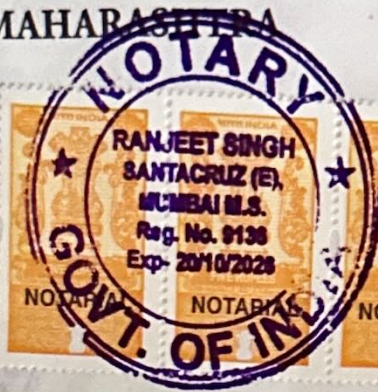

DECLARATION OF MARRIAGE



We are making this declaration to be produced before the Marriage Registrar or other concerned authorities for the purpose of registration of our marriage.

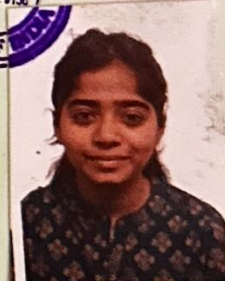

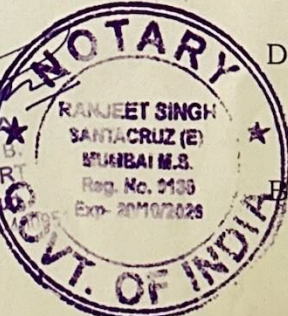
