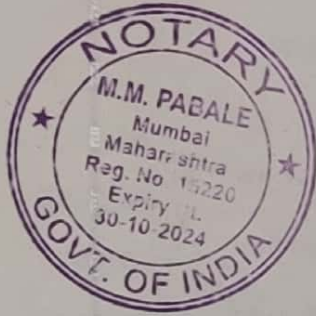

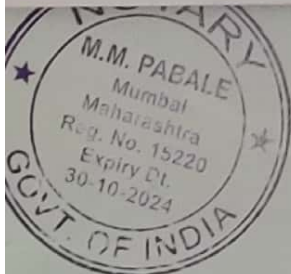

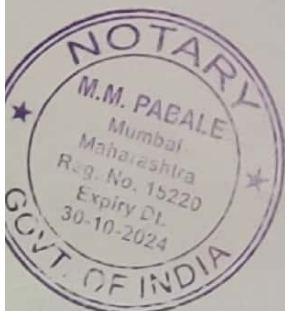

Madhuri Mohan Shingade was born at Solapur, Maharashtra on 30.10.1985.



7. We say that we are making this affidavit for the purpose of putting on record the fact of our marriage and for submitting the present Affidavit to the concerned authority.





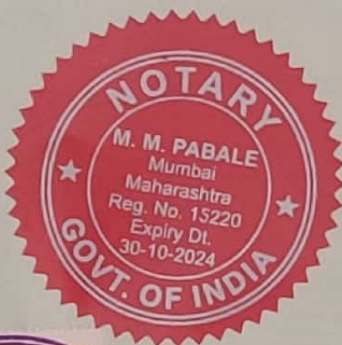


