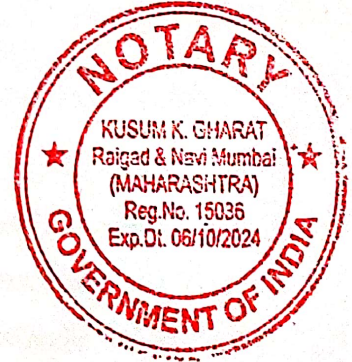
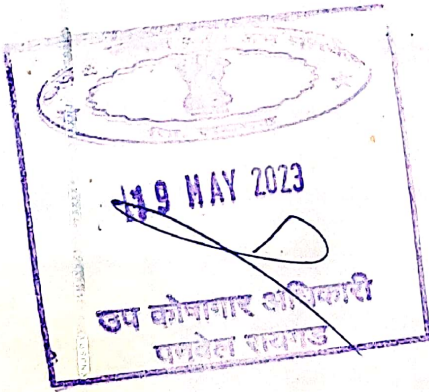

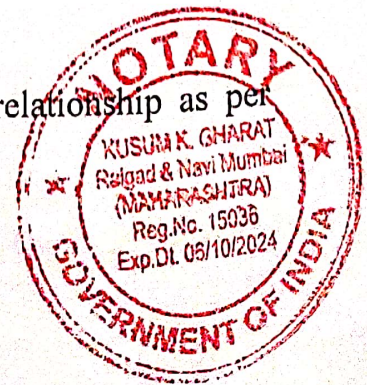


MARRIAGE AFFIDAVIT

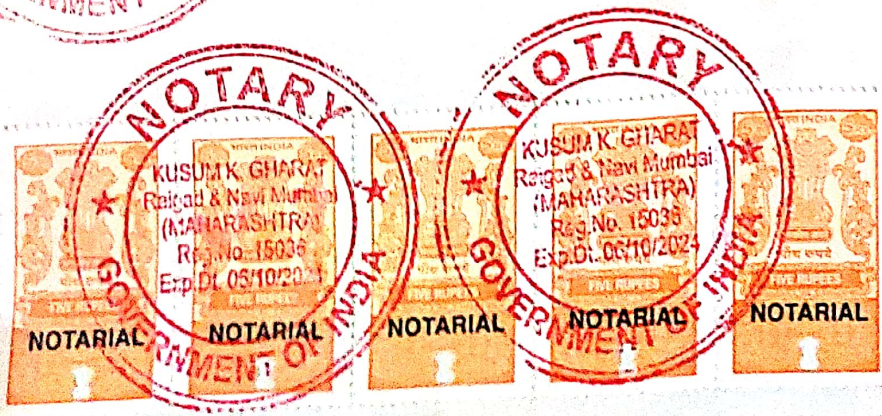
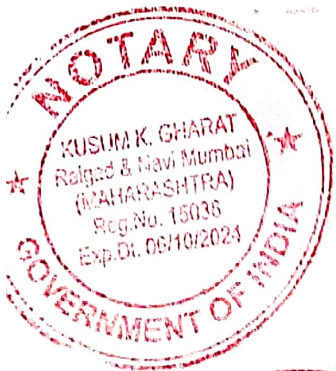
