



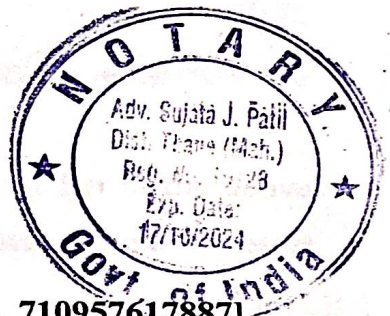

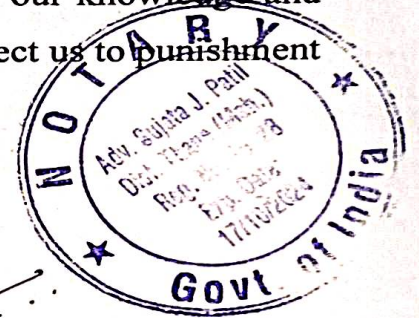
- i) We state and declare that we are **Indian Citizens**.
