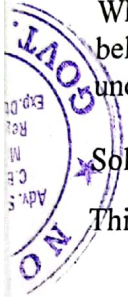
- i) We state and declare that we are Indian Citizens.

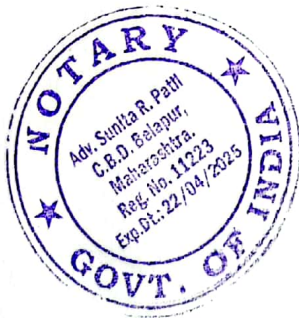
