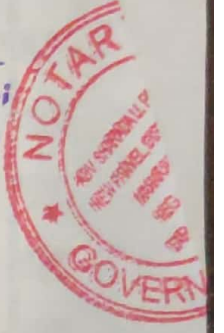

The marriage between us solemnized as per Hindu Rites in the presence of our family members and relatives.




