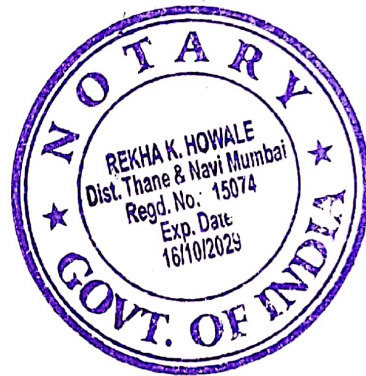
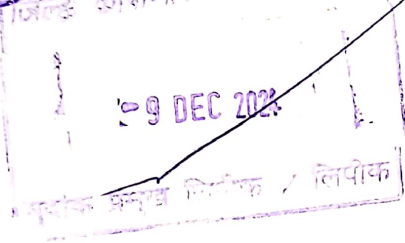

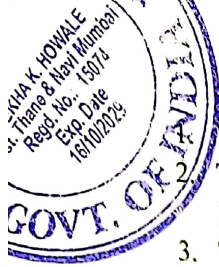
OUT OF STATE MARRIAGE -AFFIDAVIT

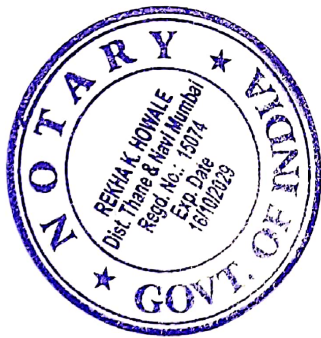


We state and declare that we are **Indian Citizens.**
