I deponent No. 2 says that after marriage I shall be known as **MRS. NEHA NAVNATH KHARAT.**

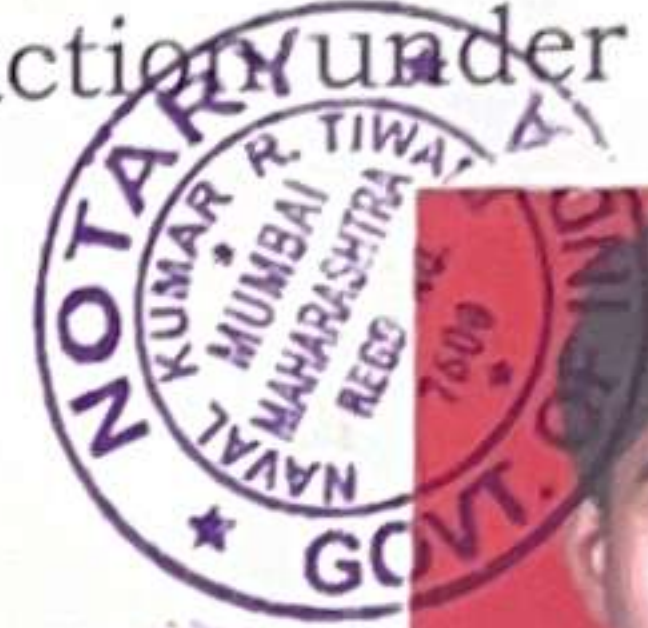
