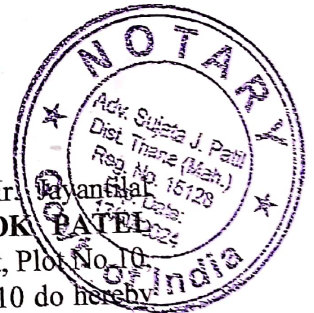

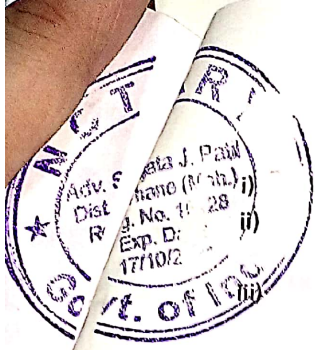

That my date of birth is **15/08/1981** and my wife's date of birth is **05/07/1987**.

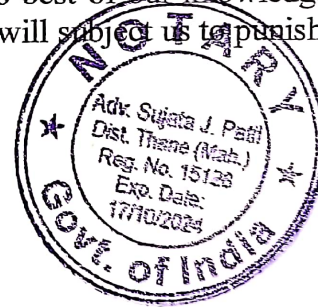
