

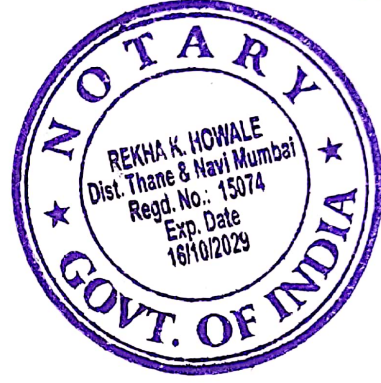

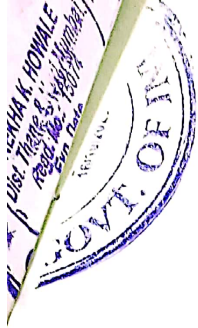


### MARRIAGE AFFIDAVIT

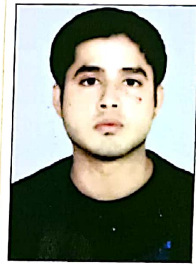

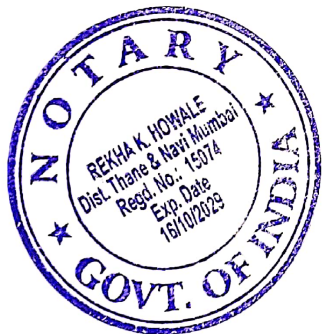
1. We state and declare that we are **Indian Citizen**.
