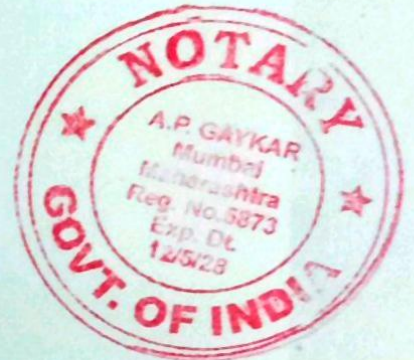

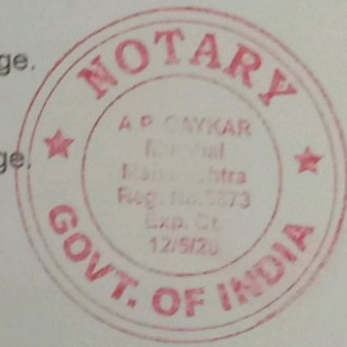

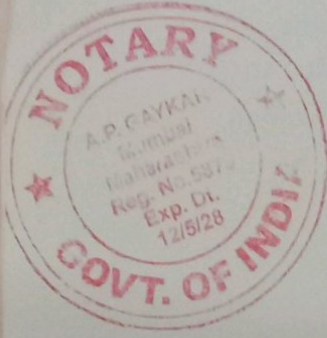

12. That the following three witnesses were present at the time of our marriage,



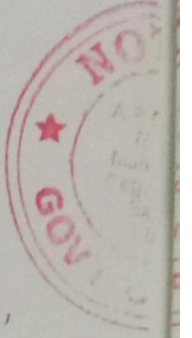

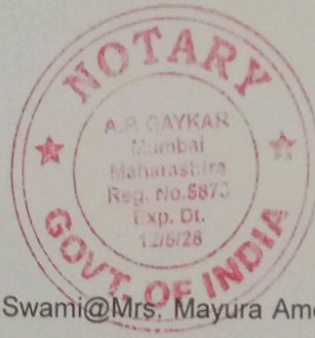

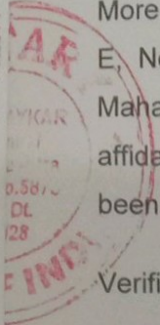
