We are citizens of India.

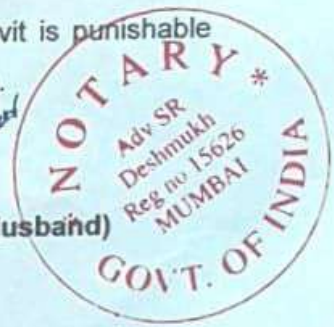



