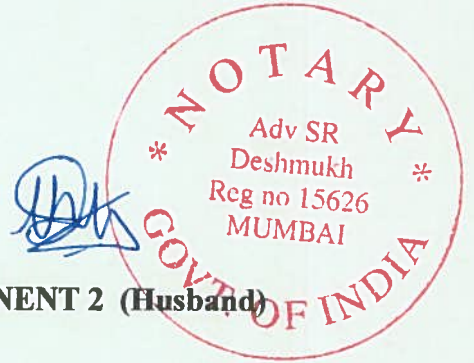
1. We are citizens of India, Religion:- HINDU.
