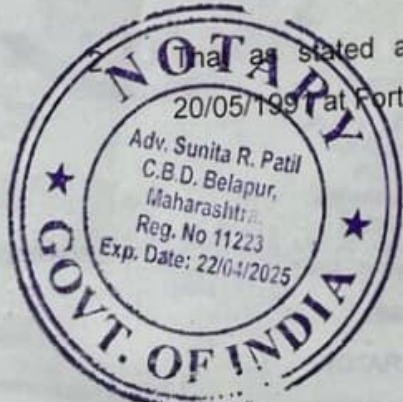
**MARRIAGE AFFIDAVIT**
